She has been teaching the word of God to help people who lives have fallen apart because of pot. She questioned the price for mini golf, stating she heard it was going to be \$5.00 and now the cost \$7.00.

Charles Ailing-8130 E. Britton Dr. spoke about the recent accident at the corner of E. Britton and Lockport Rd. and questioned what can be done to make this corner safe. On 5/2/2024 he counted 189 cars pass that corner within a ½ hour, (11:30-Noon) and that is without any of the truck traffic that Amazon will create. Maybe the Town can place white striping in the road to make it more visible for traffic to know where exactly to stop. He also questioned if it would be possible to make E. Britton a one way road.

Tom Webber-7625 Packard Rd. He wanted to see if there are any open permits for 7701 Packard Rd. He is interested in buying the property. He stated the property has not be maintained, there have been sewage issues and property has dead rodents on it. He also spoke about Packard Rd. being narrow and not enough room for 2semi trucks to pass, especially if there are cars parked on the side of the road and it needs to be addressed. One packet of photos were handed in to be included in the minutes. Mr. Webber also handed out packets #1, #2, and #3 containing pictures for the board to view but then took them back at the end of the meeting.
